Terms and conditions of the contest

Article 1: dates of the contest

The company CONSTRUCTIONS NAUTIQUES NICOL'S YACHT said NICOLS - Company by Simplified Shares, with a capital of 152,000 euros, with its headquarters at Route du Puy Saint Bonnet, 49300 CHOLET (France) and registered in Angers under the registration number B 338 576 374, is putting together a giveaway contest from **November 1st 2023 at 12:01 am to November 31st 2023 at 11:59 pm.**

Article 2: platform of the contest

This giveaway contest is free, with no obligation to purchase. It is advertised on the website www.nicols.com, on the Facebook page www.facebook.com/pages/les-bateaux-nicols as well as by email to the Nicols client database.

Article 3: how to enter the contest

This giveaway contest is open to everyone over 18 years old, living in France or abroad, with the exception of Nicols employees and their family (with the same last name and same address).

Entering the giveaway contest implies being fully aware and agreeing to the present terms and conditions.

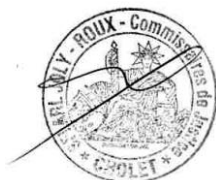
Participants can only enter once, under one first and last name and address, for the entire duration of the contest.

To enter, the participant must go to the page <https://avis.nicols.com/2023-giveaway-contest/> (in English) or <https://avis.nicols.com/gewinnspiel-2023/> (in German) and share with Nicols (one category per entry):

- **Pictures** of their Nicols holidays, in a digital format, with a **minimum resolution of 2000 pixels in width**. Pictures can be of the boat itself or life on board, of landscapes, architecture, activities around the boat (fishing, swimming, having a picnic) , or even quirky and out of the ordinary pictures.
- OR a **video** montage of their Nicols holidays, in the format .avi, .mov, .mpeg, .mpeg4, .wmv. The video must not exceed a duration of **5 minutes**.
- OR a **written account** of their Nicols holidays in the manner of a travel journal. The text must be **at least 400 words**, and include at least **3 pictures** of the cruise.

Participants can enter three ways:

- By uploading their files via We Transfer to the email address web@nicols.com

Participants agree that the content of their text, pictures and videos:

- Do not cause any harm to public decency or hurt the sensitivity of children

- Are not denigrating, degrading or defamatory to Nicols or to any physical or moral entity, in any way
- Do not infringe anybody's right to intellectual property

In the eventuality that these criteria should not be met, Nicols reserves the right to refuse the participant's entry and not post their text, pictures or videos without any possible dispute from the participant.

Participants give Nicols full access to use and reproduce the contents they provide. 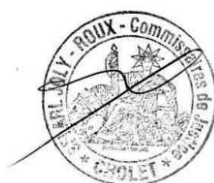
One winner will be designated for each category among all participants, by an internal jury made up of the director and of the webmaster. The three winners will be chosen between December 1st 2023 and December 15th 2023.

Article 4: prizes of the contest

There is a chance to win the following prizes:

- For the best video in the category "Lights, Camera, Action!": **1 short-break cruise*** (3 days and 4 nights) with a maximum value of 2075€ (tax included)
- For the best written story in the category "Travel journal": **1 weekend cruise*** (2 days and 2 nights) with a maximum value of 1596€ (tax included)
- For the best picture in the category "Through your camera lens": **1 mini-cruise*** (1 day and 1 night) with a maximum value of 480€ (tax included)

*These prizes must be used during the 2024 season (except during the period between June 6th 2024 and August 23rd 2024) on a 2-cabin boat that can sleep 4-6 people. The winner will be able to pick the boat of their choosing among all available Nicols boats (except FLY range and Sixto



Prestige C) from the following bases : Dole in Franche-Comté, Saverne in Alsace, Venarey in Burgundy, Le Somail or Port Lauragais on the Canal du Midi, Bellegarde in the Camargue, or Glénac in Brittany. The cruise will be free of charge with the exception of meals, fuel consumption, optional extras and security/cleaning deposits upon boarding.

The prize only includes what is previously mentioned and excludes (non-exhaustive list): transportation costs, parking costs, meals costs, tourist tax, personal expenses, etc... **These costs are the exclusive responsibility of the winner** and the people going along with them.

Article 5: winner information

Nicols will inform the winners by registered mail (with proof of receipt) and by email, within a month following their designation. In the letter as well as in the email, winners will find the exact terms and conditions of their prize.

If Nicols is unable to contact the winner (if the address provided is incorrect, or if nobody claims the letter), the prize will be definitely lost and will not be attributed to anybody else.

The winners cannot contest their prize, ask to receive their monetary value in exchange, or for the prize to be replaced or exchanged with anything else, whether it be a goods or a service, for any reason. The prizes cannot be sold.

These prizes are indivisible and cannot be modified. If the winner does not use the entire prize, whatever is left unused will be lost. If, for any reason independent from Nicols, the winner cannot use their prize, it will be definitely lost and will not be attributed to anybody else.

Article 6: rules of the contest

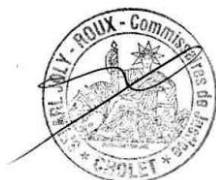
Entering the giveaway contest implies being fully aware and agreeing to the present terms and conditions, without any reservations.

Anybody who requests it can also receive a paper copy of this document, by sending their request to Nicols before November 30th 2023 at: Nicols, Jeu Concours, Route du Puy Saint Bonnet, 49300 Cholet. Only one paper copy will be sent per last name and per address. Nicols will not be responsible for the cost of mailing the rules of the contest, as the document is available online.

Article 7: modification of the conditions of the contest

In case of *force majeure*, Nicols can, at any time, make modifications to the contest, or interrupt it temporarily or permanently, without being responsible and obliged to any financial compensation that anybody might request.



Nicols can shorten, interrupt, change the terms, extend or cancel the giveaway contest if circumstances call for it (for instance, if there were any fraud during the contest or the process of allotting prizes, or in case of exceptional circumstances).

In the case mentioned above, upon noticing such event, Nicols would immediately inform the participants and the winners of its inability to maintain the contest. Nicols will not be held responsible in any way for suspending and/or cancelling the contest.

Article 8: dispute

Processing your personal data

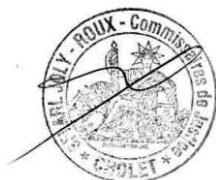
When you decide to enter a contest, you agree for your personal data to be processed.

Where does your data go?

How do we use your personal data?

This personal data can be used for commercial purposes (mailing, email, text message or other). This use will only be internal and Nicols will not sell or post any files or information, with the exception of your stories/pictures/videos.

How long do we store your personal data?

Personal data will be stored for a total of 2 years starting from the end of the contest.
